
महोदय,

Standard Procedure of Cash remittance across the Banks

Cash remittance from Currency Chests / Branches:

- Cash remittance is being made through Bank's cashier / officers only.
- Staff deputed for remittance must carry ID cards and authority letter from the concerned branch / CC.
- A certificate duly signed and stamped by the Branch / Currency chest certifying the vehicle being used for cash remittance.
- Cashier / Officers must be accompanied by peon / guards depending upon the amount of cash being remitted.
- Guards and driver must carry their ID cards and licenses.
- Branch remitting cash must write a letter / schedule with denomination detail of cash being remitted. Branch / currency chest must ensure that the letter/schedule is signed and stamped.

Cash Replenishment in ATMs:

- CRA (Cash Replenishment Agency) carrying cash for replenishment in ATM must be carrying copy of agreement /authorization letter from respective bank.
- CRA to give an authority letter certifying vehicles being used for cash replenishment in ATM's of Banks.
- Custodians/Guards/Driver must carry their ID Cards, licenses and Indent from MSP (Master Service Provider) along with ATM ID wise detail of cash to be loaded.
- CRA carrying cash must carry the counter / receipt generated from ATM's for cash filled in the respective ATM's.
