
Sir/Madam,

1. The Commission attaches a lot of importance to the Weekly Reports on Poll Preparedness submitted by the CEOs and carefully examines and analyses the inputs and details provided in these Reports. These Weekly Reports provide a snapshot of the activities and preparedness of the State Election Machinery and reflects significantly on the overall performance. Hence, the seriousness and significance of these Weekly Reports and the imperative of ensuring their accurate and careful compilation and timely submission must be duly underscored and emphasized.
2. The CEOs must ensure that the Format of the Weekly Reports is percolated down to the DEO level and the system of preparing, compiling, consolidating and submitting the Weekly Report is properly and duly institutionalized for facilitating systematic and purposeful review and monitoring of the various election preparedness activities and protocols in the State.
3. The Weekly Report in the prescribed format must be submitted by the CEOs latest by 12 noon on every Monday by email to Shri Sumit Mukherjee, Secretary (Planning) and the DEC/DG concerned, so that the same are compiled and submitted to Hon'ble CEC as per his directions.
4. The Weekly Reports shall be sent under the hand and seal of the CEO concerned.
